# **Privacy Policy**

This Privacy Policy ("Policy") applies to camieharvey.com, and Camie Harvey ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include camieharvey.com. The Company's website is a therapy services site. By using the Company website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

# **Sharing Information with Third Parties**

## **Tracking User Behavior**
